REQUIREMENTS TO PAY RHODE ISLAND SALES & USE TAX

You are obligated by law to pay seven percent (7%) sales/use tax if, at the time of purchase, you were a Rhode Island resident, either wholly or partially. Credit for sales/use tax legally due and paid to another state is allowed.
